Contract was extended for May/June 2005 and included the inflation factor of 3.10%. This contract has been extended A second year for May/June 2006 and includes the inflation factor of 2.6%. Also included in the South Region Purchase Order, is the delivery fee of \$400 to bring six #2700 bags of Calcium Chloride to the Homer area.
