GOOD EVENING LADIES AND GENTLEMEN OF THE KENAI PENINSULA---THE ASSEMBLY--- THE ADMINISTRATION--- THE AUDIENCE, AND THE LISTENING PUBLIC---AS ALASKAN RESIDENTS---YOU ARE LEGALLY IDENTIFIED WITHIN OUR STATE CONSTITUTION AS "ITS PEOPLE".

MY NAME IS SHERMAN C. "RED" SMITH--- I CAME TO ALASKA IN 1948 AND HAVE LIVED IN COOPER LANDING SINCE NOVEMBER OF 1949--- MANY OF YOU WILL RECALL SOME OF MY EARLIER COMMENTS---ABOUT OUR UNIQUE STATE CONSTITUTION---AND THAT PORTION OF OUR FEDERAL CONSTITUTION KNOWN AS "THE BILL OF RIGHTS".

THAT IS WHAT AMERICANS FOUGHT A REVOLUTION FOR--- AND WHAT I FOUGHT FOR IN WWII--- THOSE TWO DOCUMENTS---THE RULE OF LAW---IS WHAT I AM FIGHTING FOR HERE TONIGHT.

WHEN I ENLISTED IN THE US MARINES---ON DECEMBER 8, 1941---I SWORE I WOULD DEFEND THIS NATION AGAINST ALL ENEMIES---BOTH FOREIGN AND DOMESTIC-- I STILL WILL---I STILL AM..

ARE THERE ANY ADULTS LISTENING TO ME---TONIGHT--- THAT DO NOT THINK YOU HAVE A CONSTITUTIONAL RIGHT TO TRIAL BY A JURY OF YOUR PEERS---YOUR NEIGHBORS---IN BOTH CIVIL AND CRIMINAL MATTERS? IF THERE ARE--- PLEASE CONTACT ME PERSONALLY.

WHAT IS YOUR LIBERTY---YOUR FREEDOM---WORTH TO YOU--- WILL YOU TAKE SOME ACTON TO PROTECT YOUR RIGHT---AND MY RIGHT--- TO TRIAL BY JURY---WHICH IS THE FOUNDATION OF OUR LIBERTY.

THE RULE OF LAW---OUR CONSTITUTIONS---AND THE RIGHT TO TRIAL BY JURY--- IS THE FOUNDATION UPON WHICH AMERICAN FREEDOM WAS BUILT. REMEMBER THOSE WHO DIED TO GIVE US OUR PRESENT FREEDOM AND PROSPERITY---SHALL THEY HAVE DIED IN VAIN BECAUSE WE ARE TO LAZY---OR INDIFFERENT---TO EVEN VOTE?

WE ARE ALL BLESSED BY GOD---BECAUSE HE CREATED THIS BEAUTIFUL PART OF THE WORLD---AND---WE WERE---AND STILL ARE--- BLESSED BY MAN--- AS VERY PRIVILEDGED CITIZENS OF AMERICA.

BECAUSE---AS LONG AS YOU ARE RESIDENT IN ALASKA--- YOU ARE A MEMBER OF "ITS PEOPLE"---AND ARE EVEN BEING PAID--- ON AN ANNUAL BASIS---JUST FOR LIVING HERE.

IF YOU ALL HAD THE MEMORIES--- THAT WE TERRITORIAL ALASKANS HAVE--- OF-- PRE-CHAIN SAW--- ALASKAN WINTERS--- IN THE TENTS--- THE TAR-PAPER SHACKS--- EVEN THE CHEECHAKO VERSION OF A LOG CABIN---YOU'D UNDERSTAND WHY WE EARLY ALASKANS WROTE A TRULY UNIQUE STATE CONSTITUTION---YOU REALLY OUGHT TO READ IT.

MANY OF US CAME HERE---AS I DID---AS SURVIVORS OF A WORLD WIDE WAR---SO--- THE MISERY--- THE MUD--- AND THE MOSQUITOS--- WEREN'T VERY FRIGHTENING TO US---JUST DAMN HARD ON OUR

CHILDREN--- WHO WE TRULY WANTED TO HAVE A LIFE---IN ALASKA---A BIT EASIER AND MORE COMFORTABLE--- GRANDCHILDREN NOW.

LET ME AGAIN REMIND YOU THAT NONE OF YOU COULD OWN ANY LAND--- IN ALASKA--- WITH A FEE SIMPLE TITLE--- UNTIL SOMEONE---MAYBE YOU---TOOK IT OUT OF GOVERNMENT OWNERSHIP VIA A PATENT---NO ONE CAN TAKE ANY PART OF IT AWAY FROM YOU WITHOUT "DUE PROCESS OF LAW AND JUST COMPENSATION"---SO LONG AS THERE IS FREEDOM---AND TRIAL BY JURY OF YOUR PEERS---YOUR NEIGHBORS.

BUT THERE IS A SCHEME AFLOAT IN AMERICA TODAY--- THAT HAS NOW REACHED ALASKA--- AND THE ALASKAN COURTS.---THROUGH WHICH YOUR FREEDOM---YOUR LAND---EVEN YOUR MONEY---CAN BE TAKEN FROM YOU AGAINST YOUR WILL---. THAT ---AT THE PRESENT TIME---HAS ALL BEEN DONE TO ME---BECAUSE OF MY "CREED"---I'M A LOGGER, MINER, AND MILL MAN AT HEART---BUT HAVE WORKED FOR ALL LEVELS OF GOVERNMENT---SO I BELIEVE I UNDERSTAND HOW BAD DRIVES OUT THE GOOD.---WE CAN NO LONGER JUST "FIRE" THEM.

ONCE THE PRECEDENT IS SET IN CASE LAW---IT CAN BE DONE TO YOU. ---HOW?-- HOW CAN SUCH A THING BE HAPPENING IN AMERICA---IN ALASKA--IN OUR LOCAL COURTS---EVEN IN KENAI?

ITS QUITE SIMPLE---REALLY---ITS QUITE EASILY DONE.--- IT IS BEING DONE TO CITIZENS BY ROGUE JUDGES---JUDGES WHO WILL VIOLATE THEIR SUBSCRIBED "OATH OF OFFICE"---"TO SUPPORT AND DEFEND THE CONSTITUTION OF THE UNITED STATES---AND THE CONSTITUTION OF THE STATE OF ALASKA"--- AND DENY THE CITIZEN THE RIGHT TO TRIAL BY JURY---TO THE "LIBERTY"---TO THE "EQUAL RIGHTS, OPPORTUNITIES, AND PROTECTION UNDER THE LAW"---"AND THE ENJOYMENT OF THE REWARDS OF THEIR OWN INDUSTRY"---. WHICH ARE ALL PART OF "THE RULE OF LAW" ---ALASKA'S CONSTITUTION.

ROGUE JUDGES "SUPPORT"---AND IMPOSE--- "THE RULE OF MAN". BUT ONLY SO LONG AS WE ALLOW THEM TO SIT--- IN THEIR ROBE--- IN THEIR COURT-ROOM--- IN ALASKA---WE DO NOT VOTE THEM IN---BUT---WE CAN VOTE THEM OUT.

HOW CAN SUCH UNJUST TREATMENT BE ACCOMPLISHED? --IT IS ACCOMPLISHED BY ALL THE SKILLFUL LIES--- FRAUDULENT AFFIDAVITS---PERJURED TESTIMONY---AND BUREAUCRATIC HOG-WASH--- THAT IS ACCEPTED BY THE JUDGE---WITHOUT ANY TRIAL BY JURY ON THE ISSUES OF FACT---. RED SMITH---AND YOU---ARE PRESUMED---BY THE JUDGE---TO BE THE LIARS---BUT A JURY WOULD NOT MAKE THE SAME PRESUMPTION--- HAVE YOU NOTICED THAT THE WORD GOD IS BEING TAKEN OFF OF---AND OUT OF---OUR GOVERNMENT.

THE CITIZEN---(RED SMITH--OR YOU) CAN BE SLANDERED---LIBELED---BUREAUCRATICALLY HARASSED--- FINED \$5,000 AND PUT ON PROBATION FOR A YEAR---EVEN PENALIZED THROUGH TAX

APPRAISALS---AND WITHOUT ACCESS TO THE COURTS---AND A TRIAL BY JURY--- YOU WILL FIND YOURSELF VIRTUALLY HELPLESS.

SUCH IS THE PRESENT SITUATION THIS COMBAT VETERAN---OF WWII---AND 58 YEAR RESIDENT OF ALASKA---FINDS HIMSELF IN--- WOULD YOU LIKE TO JOIN ME---AND SUFFER SUCH UNJUST TREATMENT---OR WILL YOU JOIN ME---AND TAKE ACTION TO SEE THAT IT DOES NOT HAPPEN TO YOU---OR YOURS.

AND IF THE ROGUE JUDGE TAKES YOUR GRANDCHILDREN AWAY FROM A FATHER-- WHO GAVE THEIR HOME TO THE CHILDREN'S MOTHER---AND WILL---FOR YEARS---IGNORE THE PLEAS OF FAMILY MEMBERS---ALONG WITH THE FATHER ---WHO BUILT A NEW HOME---FOR CUSTODY OF THEIR KIN---AND--- WHEN THE MOTHER BECAME DRUG ADDICTED---AND HOMELESS--- JOIN HIS COLLEAGUES---IN ANCHORAGE--- IN THE "CHINA" COURTS---AND PLACE YOUR GRANDCHILDREN IN THE TENDER---LOVING---CARE OF A LOBBYIST---A FOSTER FATHER---A MARIJUANA SMOKER---WHO WILL ALLOW YOUR GRANDCHILDREN TO BECOME DRUG ADDICTS BEFORE THEY GET OUT OF HIGHSCHOOL---THEN YOU WILL KNOW HOW DIFFICULT IT IS FOR AN OLD WARRIOR TO REMAIN PEACEFUL.

ARTICLE 8, SECTION 16---AND ARTICLE 3, SECTION 16---OF ALASKA'S CONSTITUTION ARE THE PROTECTION "ITS PEOPLE" (YOU---AND I---AND OUR PROGENY)---NOT ONLY NEED---BUT MUST HAVE ENFORCED THROUGH ARTICLE XII, SECTION 5---OR ALASKA IS NOT A STATE---AND WE HAVE NO FUTURE---AS FREE PEOPLE.

ROGUE JUDGES--- IN STATE---OR FEDERAL---COURTS---WILL---ALL TOO OFTEN---ONLY PLAY POLITICS.

OVER A SIX (6) YEAR PERIOD OF TIME 2000-2006---WE GAVE STATE SUPERIOR COURT JUDGE---HAROLD M. BROWN---THREE (3) CHANCES TO "SUPPORT AND DEFEND" THE CONSTITUTIONS--- AND THEIR GUARANTEE OF OUR RIGHT TO TRIAL BY JURY---WHICH IS THE RULE OF LAW.

HE PLAYED POLITICS---CHOSE THE RULE OF MAN---HIMSELF---AND HAS DENIED THIS CITIZEN HIS "LIBERTY" BY DENYING HIM HIS RIGHT TO A TRIAL BY JURY.



WE---YOU AND I---"ITS PEOPLE"---NEED HONORABLE JUDGES WHO WILL---IN FACT---HONOR THEIR OATH OF OFFICE. WE---YOU AND I---"ITS PEOPLE"---DO NOT NEED A JUDGE LIKE HAROLD M. BROWN.

THANK YOU FROM THE BOTTOM OF THE HEART OF A WWII COMBAT
VETERAN---AND FROM THE TOP OF IT TOO.--- WAVE---OR HONK---IF YOU
SEE ME ON A PROPERTY THEY PLAN TO TAKE---ON KENAI LAKE--- YOU
DRIVE RIGHT THROUGH IT EVERY TIME YOU GO TO ANCHORAGE---OR
SEWARD--- IT'S SO BEAUTIFUL THAT I'LL EVEN BE THERE AFTER I DIE---AT
KENAI LAKE---IN COOPER LANDING.
