Haggerty moved to amend Ordinance 2012-06 as follows:

Title to read, "An Ordinance Amending KPB <u>21.18.025(B)</u> 21.18.081, [21.18.100], and 21.18.140 to Permit Certain Structures in Tidally Inundated Areas, and Conditionally Permit Certain Structures within the Habitat Protection District and Adding Definitions"

Insert a new Section 1 to read, "That KPB 21.18.025 (B) is hereby amended as follows:

B. In addition to the water bodies listed in 21.18.025(A), all anadromous waterbodies within the municipal boundaries of the Kenai Peninsula Borough which are listed in the "Atlas and Catalogue of Waters Important for Spawning, Rearing, or Migration of Anadromous Fish" as periodically updated and published by the Alaska Department of Fish and Game[, EXCLUDING ALL PORTIONS OF WATERWAYS FOUND WITHIN THE SEWARD-BEAR CREEK FLOOD SERVICE AREA,] are subject to this chapter as of January 1, 2012, excluding the following:

1. All portions of waterways found within the Seward-Bear Creek Flood Service Area are

exempt from KPB 21.18,

2. Braided Channels, Tide Dominated Deltas, Estuaries and Lagoons which are primarily seawater and are identified as anadromous in the State of Alaska Atlas and Catalogue of Waters Important for Spawning, Rearing, or Migration of Anadromous Fish are exempt from KPB 21.18."

Renumber existing section accordingly.

Newly renumbered Section 2 to read, "That KPB 21.18.081(B) is hereby amended by adding a new provision as follows:

. .

- 10. A principal structure or an addition to a principal structure may be approved within the habitat protection district provided all the following standards are met:
- a. The parcel boundaries were defined prior to January 1, 2012.
- b. The parcel [IS SUBJECT TO A CITY BUILDING CODE AND] is served by a public sewer system or sewage holding tank or septic system, provided the holding tank or septic system are located entirely outside the habitat protection district.
- c. The parcel has an area of .3 acres or less and less than 4,000 square feet of total developed impervious coverage.
- d. The parcel has less than 4,000 square feet of suitable development area outside the habitat protection distrct.

[D] <u>e</u>. On the portion of the parcel within the habitat protection district, the total impervious coverage may not exceed 50% of the area able to sustain native vegetation, or [5,000] <u>3,000</u> square feet of area able to sustain native vegetation, whichever is less.

[E] <u>f</u>. The standard for development is to <u>first</u> utilize suitable parcel areas outside the habitat protection district [AS A PREFERRED ALTERNATIVE TO DEVELOPMENT WITHIN A HABITAT PROTECTION DISTRICT.] Within the habitat protection district, it is preferred to minimize impact by preserving the nearshore areas which may sustain native vegetation."

E. BUILDING PERMITS ISSUED BY A CITY FOR AREAS SUBJECT TO TIDAL INUNDATION, BETWEEN MEAN HIGH WATER AND MEAN HIGHER HIGH WATER, WILL CONSTITUTE A DETERMINATION THAT THE REQUIREMENTS OF KPB 21.18 ARE SATISFIED AND THE PROJECT IS EXEMPT FROM KPB 21.18 APPLICATION.]"

Renumber remaining sections accordingly.

Insert the following additional definitions to newly renumbered Section 3, KPB 21.18.140:

AF. "Mile Zero" The downstream beginning

point of the anadromous waters identified in 21.18, and the riparian zone defined as the habitat protection district. On riverine systems subject to tidal inundation, Mile Zero begins at the elevation of mean high tide, where not otherwise designated by KPB code or prior designations.

AG. "Estuary" means a semi-enclosed coastal body of water with a free connection to the sea and in which seawater is measurably diluted with freshwater derived from land drainage.

AH. "Braided Channels" means the intertwined branches or secondary channels of a river or stream and characterized by the separation and rejoining of two or more channels separated by bars or islands.

AI. "Lagoon" means relatively shallow bodies of water, mostly-enclosed, with an oceanic source, separated by a low-lying swatch of land, such as a spit or barrier island. This oceanic source may be continual or episodic, such as storm-induced overwash, and generally has a different salinity as a result of its restricted access.

AJ. "Tide Dominated Delta" means a river delta subject to tidal inundation as well as tidal and storm erosion which may be mainly submarine with prominent bars or ridges.

ASSEMBLY COMMENTS

Assembly Member Tauriainen noted that he was encouraged to see the number of items for the Kenai Peninsula Borough that were included in the State of Alaska Capital Budget.

Assembly Member McClure thanked the Assembly for enacting Ordinance 2011-19-79 on behalf of the City of Seward, she thanked the City of Seward for their hospitality. She stated Seward Legislative Information Office was located in the SeaView Plaza, and noted the April showers were needed to control the dust.

Assembly Member Murphy thanked the City of Seward for their hospitality, she stated she had lived in Seward for twenty five-years and it was always like coming home. She noted the poor conditions of the Sterling Highway between Soldotna and Seward.

Assembly Member Haggerty thanked Assembly Member Smith for the hard work he had put into Ordinance 2012-06, he noted it was a complicated ordinance; however, it was put in place to protect the salmon, a species that could not attend the meetings and speak for itself. He noted that Seldovia City Manager, Tim Dillon had shown dedicated commitment to Seldovia with is continued involvement with the Assembly and Ordinance 2012-06. He reminded everyone that on April 24, 2012 there was going to be a recycling effort of electronics, making a tour of Port Graham, Nanwalek and Seldovia. He congratulated Homer resident Randy Wiest for finishing the Boston Marathon.

Assembly Member Johnson thanked the City of Seward for their hospitality, and stated he enjoyed meeting the City Council Members. He stated he was the Vice Chair of the Lands Committee, Sue McClure was the Chair and it had been a pleasure being taught by her.

Assembly Member Smith thanked the City of Seward for their hospitality. He stated his appreciation for Mayor Navarre traveling to Juneau and his representation of the Kenai Peninsula Borough needs.

Assembly Member Smalley thanked the City of Seward for their hospitality, he noted that Seward was a favorite place of one of his grandsons. He thanked Assembly Member Smith, the River Center Staff, Administration and Seldovia for the efforts put into Ordinance 2012-06 to get all of the problems corrected. He noted that Ordinance 2012-06 was not popular when it when it was first introduced; however, continued work is fixing it. He thanked Mayor Navarre for his efforts in Juneau, and noted it had made a difference in what would be happening on the Peninsula.

Vice President Pierce said the efforts of Mayor Navarre in Juneau were evident in the State of Alaska Capital Budget. He stated that the borough funds spent to travel to Juneau in an effort to represent the constituents needs clearly made a difference. He thanked the City of Seward for their hospitality.

President Knopp thanked the City of Seward for their hospitality, and noted how much he enjoyed coming to Seward. He thanked Mayor Navarre and Chief of Staff Paul Ostrander for the work done in Juneau. He thanked Assembly Member Smith for the amendments made to Ordinance 2012-06. He stated during his time on the Assembly there had been three administration, and each administration had strived to do their best. He stated that the Williams administration had lowered mill rates and shifted the tax burden, Carey had done some nice things, and now Mayor Navarre was doing great thing early on in his tenure. He noted the benefits to the Kenai Peninsula Borough having the current representation in Juneau. He noted the monies received from the state benefited everyone economically.
