**KENAI PENINSULA BOROUGH  
ORDINANCE 2006-19-34**

**AN ORDINANCE ACCEPTING A GRANT FROM THE ALASKA  
DEPARTMENT OF EDUCATION AND EARLY DEVELOPMENT IN  
THE AMOUNT OF \$262,500 AND APPROPRIATING THE GRANT AND  
\$112,500 IN MATCHING FUNDS TO A CAPITAL PROJECT ACCOUNT  
FOR SCHOOL HVAC CONTROL UPGRADES, AND \$11,064  
IN ADMINISTRATIVE SERVICE FEES**

**WHEREAS,** the Kenai Peninsula Borough School District and the Borough Maintenance Department compiled a list of school capital improvement projects that were included in the Borough's 2006 State Funding Priorities; and

**WHEREAS,** the Borough's 2006 State Funding Priorities included a request for funding for upgrades to heating, ventilation, and air-conditioning (HVAC) at various schools within the school district; and

**WHEREAS,** notice has been received from the Alaska Department of Education and Early Development that funding in the amount of \$262,500 is available for HVAC upgrades within the Borough School District; and

**WHEREAS,** the grant program requires a local match in the amount of \$112,500, providing a total of \$375,000 for the project; and

**WHEREAS,** matching funds in the amount of \$112,500 and \$11,064 for administrative service fees are available in the School Revenue Capital Project Fund fund balance; and

**WHEREAS,** the performance period for this grant is from July 1, 2006, through July 1, 2011; and

**WHEREAS,** acceptance of this grant will benefit several schools throughout the Borough;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept a grant from the Alaska Department of Education and Early Development in the amount of \$262,500 for HVAC upgrades at Borough schools and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.

**SECTION 2.** That grant funds in the amount of \$262,500 are hereby appropriated to account 400.78050.07009.49999, areawide capital project account.


**SECTION 3.** That the following amounts are appropriated from account 400.00000.00000.27910, School Revenue Capital Project Fund Balance, to the below listed accounts:

\$112,500 to account 400.78050.07009.49999, areawide capital project account;  
\$11,064 to account 400.78050.07009.61990, administrative service fee.


**SECTION 4.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

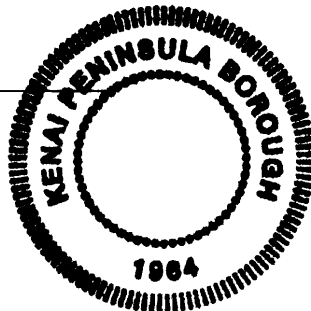
**SECTION 5.** This ordinance shall become effective immediately upon its enactment.
