KENAI PENINSULA BOROUGH ORDINANCE 2010-19-29

AN ORDINANCE ACCEPTING AND APPOPRIATING \$128,882.84 FROM THE U.S. DEPARTMENT OF INTERIOR FOR THE PLANNING AND ADMINISTRATION PROJECT UNDER THE COASTAL IMPACT ASSISTANCE PROGRAM

- WHEREAS, the Coastal Impact Assistance Program (CIAP) was established under Section 384 of the Energy Act of 2005 and authorizes the Secretary of the Interior to disburse funds to Outer Continental Shelf oil and gas producing states; and
- WHEREAS, the purpose of the CIAP is to provide funding through a non-competitive grant process to oil and gas producing states to mitigate the effects of offshore oil and gas activities; and
- WHEREAS, eligible recipients of CIAP funds in Alaska are those communities that participate in the Alaska Coastal Management Program, which includes the Kenai Peninsula Borough; and
- WHEREAS, eligible recipients are required to submit a list of approved projects to the Alaska Department of Natural Resources, and upon their approval the projects are forwarded to the U.S. Minerals Management Service, henceforth known as the Bureau of Ocean Energy Management, Regulation and Enforcement (BOEMRE), for final approval; and
- WHEREAS, the Planning and Administration Project was approved by the Kenai Peninsula Borough Assembly through adoption of KPB Resolution 2007-032 and Resolution 2009-018; and
- WHEREAS, BOEMRE has approved CIAP funds in the amount of \$154,383.06 to complete the Planning and Administration Project, of which \$25,500.22 has been approved and appropriated by way of ordinances 2008-19-50 and 2009-19-12; and
- WHEREAS, this ordinance will approve the remaining funds in the amount of \$128,882.84 to complete the total project; and
- WHEREAS, the assembly finds it is in the best interest of the Kenai Peninsula Borough to participate in the Coastal Impact Assistance Program;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept the remaining funds from the U.S. Department of Interior, Bureau of Ocean Energy Management, Regulation and Enforcement in the amount of \$128,882.84 through its Coastal Impact Assistance Program, and is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the grant and fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That grant funds totaling \$128,882.84 are hereby appropriated to account number251.21135.15160.49999, CIAP Planning and Administration, for the purpose of completing the Planning and Administration Project approved in KPB Resolution 2009-018.
- **SECTION 3.** That due to the length and nature of this project, the appropriation established through the ordinance shall not lapse at the end of any particular fiscal year.

SECTION 4. This ordinance shall become effective immediately upon enactment.
