KENAI PENINSULA BOROUGH ORDINANCE 2010-19-36

AN ORDINANCE ACCEPTING AND APPROPRIATING \$36,272 FROM THE U.S. DEPARTMENT OF INTERIOR FOR THE RECREATION AREA SANITATION PROGRAM UNDER THE COASTAL IMPACT ASSISTANCE PROGRAM

- WHEREAS, the Coastal Impact Assistance Program (CIAP) was established under Section 384 of the Energy Act of 2005 and authorizes the Secretary of the Interior to disburse funds to Outer Continental Shelf oil and gas producing states; and
- WHEREAS, the purpose of the CIAP is to provide funding through a non-competitive grant process to oil and gas producing states to mitigate the effects of offshore oil and gas activities; and
- WHEREAS, eligible recipients of CIAP funds in Alaska are those communities that participate in the Alaska Coastal Management Program, which includes the Kenai Peninsula Borough; and
- WHEREAS, eligible recipients are required to submit a list of approved projects to the Alaska Department of Natural Resources, and upon its approval the projects are forwarded to the U.S. Minerals Management Service, henceforth known as the Bureau of Ocean Energy Management, Regulation and Enforcement (BOEMRE) for final approval; and
- WHEREAS, the Recreation Area Sanitation Project, formerly called the Area Wide Sanitation Project, was approved for funding by the Kenai Peninsula Borough Assembly through adoption of KPB Resolution 2009-018; and
- WHEREAS, the borough has received a grant award from BOEMRE for the Recreation Area Sanitation Project in the amount of \$36,272; and
- WHEREAS, the assembly finds it is in the best interest of the Kenai Peninsula Borough to participate in the Coastal Impact Assistance Program;
- NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:
- SECTION 1. That the mayor is authorized to accept the Recreation Area Sanitation Project grant funds from the U.S. Department of Interior, Bureau of Ocean Energy Management, Regulation and Enforcement in the amount of \$36,272 through its

Coastal Impact Assistance Program, and is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the grant and fulfill the intents and purposes of this ordinance.

- **SECTION 2.** That grant funds totaling \$36,272 are hereby appropriated to the following account number for the purpose of completing the project approved in KPB Resolution 2009-018: 271.21135.11051.49999
- **SECTION 3.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 4. This ordinance shall become effective immediately upon its enactment.
