**KENAI PENINSULA BOROUGH
ORDINANCE 2010-19-40**

**AN ORDINANCE AUTHORIZING AND APPROPRIATING FUNDS FOR CENTRAL
PENINSULA GENERAL HOSPITAL, INC. TO PURCHASE COMPUTERIZED
PROVIDER ORDER ENTRY AND CONTINUITY OF CARE DOCUMENT
EXCHANGE SYSTEMS**

WHEREAS, Central Peninsula General Hospital, Inc. (CPGH, Inc.) must comply with new federal guidelines regarding electronic medical records that take effect in 2012 and 2013; and

WHEREAS, the purchase of computerized provider order entry and continuity of care document exchange systems will assist it in complying with these requirements; and

WHEREAS, Meditech software is currently utilized for clinical and business functions at Central Peninsula Hospital; and

WHEREAS, the cost for computerized provider order entry and continuity of care document exchange systems is \$455,148; and

WHEREAS, funding for this purchase would be paid from the CPGH, Inc. Plant Replacement and Expansion Fund; and

WHEREAS, the CPGH, Inc., board at its March 31, 2011, meeting approved the purchase of the Computerized Provider Order Entry and Continuity of Care Document Exchange Systems from the CPGH, Inc. Plant Replacement and Expansion Fund; and

WHEREAS, the Central Kenai Peninsula Hospital Service Area Board at its May 2, 2011, special meeting recommended approval without objection;


NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That Central Peninsula General Hospital, Inc. is authorized to purchase the Computerized Provider Order Entry and Continuity of Care Document exchange systems for an amount not to exceed \$455,148.

SECTION 2. That \$455,148 in CPGH, Inc. Plant Replacement and Expansion funds are appropriated to account no. 490.81110.11CCD.48516 for the purchase authorized in section 1 of this ordinance.

SECTION 3. That this ordinance is takes effect immediately upon its enactment.

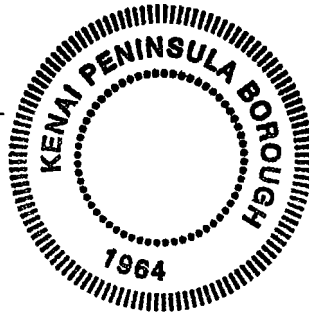
