AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT IN THE AMOUNT OF \$33,110 FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY FOR STAFF RECRUITMENT AND APPROPRIATING \$1,007 IN THE BEAR CREEK FIRE SERVICE AREA FOR THE ADMINISTRATIVE FEE

- WHEREAS, the Bear Creek Fire Service Area (BCFSA) is committed to the health and safety of its firefighters and intends to meet this goal by continued recruitment and training; and
- WHEREAS, the U.S. Department of Homeland Security (DHS) provides annual application through the Assistance to Firefighters Grant (AFG), which assists rural fire departments with funding for operations and safety; and
- WHEREAS, BCFSA applied for funding to assist with recruiting "front-line" firefighters through the AFG "Staffing for Adequate Fire and Emergency Response" program; and
- WHEREAS, BCFSA has received notice of a grant award in the amount of \$33,110.00 through the 2010 AFG program; and
- WHEREAS, pursuant to KPB Resolution 2006-036, an administrative fee of 3.04 percent of the grant amount will be charged to the service area for "grants and projects that do not allow an indirect cost to be charged" and is available in the BCFSA fund balance; and
- WHEREAS, at its regularly scheduled meeting held May 10, 2011, the BCFSA Board recommended grant acceptance;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept a grant from the U.S. Department of Homeland Security in the amount of \$33,110.00 for recruiting "front-line" firefighters in Bear Creek Fire Service Area (BCFSA), and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.

SECTION 2. That funds in the amount of \$34,117.00 are appropriated as follows:

- \$33,110.00 to account no. 207.51210.00163.49999 Project account number;
- \$1,007.00 from the BCFSA fund balance to 207.51210.00163.61990 Adm Svc Fee account.
- **SECTION 3.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 4. This ordinance shall become effective immediately upon enactment.
