## AN ORDINANCE AUTHORIZING CENTRAL PENINSULA GENERAL HOSPITAL, INC. TO PURCHASE ANESTHESIA MACHINES, MONITORS AND RECORDERS AND APPROPRIATING \$671,867 FROM THE CPGH, INC. PLANT REPLACEMENT AND EXPANSION FUND FOR THE PURCHASE

- WHEREAS, the anesthesia machines in use at Central Peninsula Hospital (CPH) are becoming obsolete and have exceeded their useful life; and
- WHEREAS, the anesthesia machines were scheduled to be replaced in the late fall of FY2012 and were included in the Central Peninsula General Hospital, Inc. (CPGH, Inc.), FY2012 capital budget; and
- WHEREAS, several manufacturers were invited to CPH to demonstrate their machines to the CPH anesthesiologists and certified registered nurse anesthetists this spring; and
- WHEREAS, upon completion of the demonstrations CPH anesthesiology staff selected GE Healthcare for provision of new anesthesia machines, patient monitors and the anesthesia electronic medical record (EMR) solution; and
- WHEREAS, the cost projection for all equipment, software, and the service agreement for the anesthesia machine package is estimated to be \$693,685.00 of which \$21,818 is for the service agreement; and
- WHEREAS, the CPGH, Inc., board at its July 28, 2011, board meeting recommended approval by unanimous consent; and
- WHEREAS, the Central Kenai Peninsula Hospital Service Area board at its meeting of July 18, 2011, unanimously recommended approval of this purchase;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI **PENINSULA BOROUGH:**

**SECTION 1.** That Central Peninsula Hospital is authorized to purchase the anesthesia machines, patient monitors, and recorders and that \$671,867.00 is appropriated from the CPH plant replacement and expansion fund to account no. 490.81110.12ANS.48516.

SECTION 2. That this ordinance is takes effect immediately upon its enactment.
