**KENAI PENINSULA BOROUGH
ORDINANCE 2011-19-12**

**AN ORDINANCE ACCEPTING A GRANT IN THE AMOUNT OF \$200,000 FROM
THE STATE OF ALASKA AND APPROPRIATING \$347,226 IN THE CENTRAL
EMERGENCY SERVICE AREA CAPITAL BUDGET FOR THE PURCHASE OF
WILDLAND FIRE ENGINES**

WHEREAS, the Central Emergency Service Area (CES) requested funding to purchase a wildland fire engine in the borough's 2011 legislative priorities; and

WHEREAS, Senate Bill 46, which appropriated funding to the borough for the apparatus, was passed by the State Legislature and signed by the Governor on June 29, 2011; and

WHEREAS, notice has been received from the State of Alaska Department of Commerce, Community and Economic Development that a legislative grant has been awarded in the amount of \$200,000 to the borough on behalf of CES for the project; and

WHEREAS, the bid price on two wildland fire engines per the RFP that was recently issued including administration fees is approximately \$333,613 per wildland fire engine; and

WHEREAS, additional funds in the amount of \$133,613 are available in the CES capital project fund balance to supplement the grant fund for the purchase of the apparatus; and

WHEREAS, additional funds in the amount of \$13,613 are also needed to supplement funding of \$320,000 previously provided in FY2011 and FY2012 for the purchase of a wildland fire engine; and

WHEREAS, at its regular meeting on August 18, 2011, the CES Board of Directors recommended approval;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept, on behalf of the Central Emergency Service Area, a grant from the State of Alaska Department of Commerce, Community and Economic Development in the amount of \$200,000 for the purchase of a wildland fire engine, and is authorized to execute a grant agreement

and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.

SECTION 2. That funds in the amount of \$333,613, consisting of grant funds in the amount of \$200,000 and CES funds in the amount of \$133,613, are appropriated to project number 443.51610.12378.48514.

SECTION 3. That funds in the amount of \$13,613, are appropriated to project account 443.51610.12464.48514 to supplement funds previously provided for the purchase of wildland fire engine.

SECTION 4. That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 5. This ordinance shall become effective immediately upon its enactment.
