## AN ORDINANCE APPROPRIATING \$58,600 IN SUPPLMENTAL FUNDING FOR THE PURCHASE OF SUPPLIES AND EQUIPMENT BY THE ANCHOR POINT FIRE AND EMERGENCY SERVICE AREA

- WHEREAS, the Anchor Point Fire and Emergency Service Area (Service Area) underwent changes in personnel and operations in fiscal year 2011, which resulted in delays of purchasing needed supplies and equipment; and
- WHEREAS, the need for the supplies and equipment still exist and are required for appropriate operation of the Fire Department; and
- WHEREAS, additional funding for personnel costs is needed to hire temporary administrative staff to address deficiencies and update records prior to the upcoming ISO review and to cover the difference in the chief's salary and benefits from the FY2012 budgeted amounts; and
- WHEREAS, the service area board at its August 18, 2011, meeting authorized the use of unexpended funds from fiscal year 2011 to be utilized in fiscal year 2012, to purchase necessary items and to provide for the appropriate allocation of costs for personnel as requested below;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

**SECTION 1.** That the amount of \$58,600 is hereby appropriated from the Anchor Point Fire and Emergency Service Operating Fund, fund balance to the following accounts:
