## KENAI PENINSULA BOROUGH ORDINANCE 2011-19-20

## AN ORDINANCE ACCEPTING AND APPROPRIATING \$225,000 FROM THE STATE OF ALASKA TO THE NORTH PENINSULA RECREATION SERVICE AREA FOR THE COMMUNITY PLAYGROUND PROJECT

- WHEREAS, the North Peninsula Recreation Service Area (NPRSA) requested funding to build a community playground in the borough's 2011 legislative priorities; and
- WHEREAS, Senate Bill 46, which appropriated funding to the borough for this project, was passed by the State Legislature and signed by the Governor on June 29, 2011; and
- WHEREAS, notice has been received from the Alaska Department of Commerce, Community and Economic Development that a legislative grant in the amount of \$75,000 and a re-appropriation grant in the amount of \$150,000 have been awarded to the borough on behalf of the North Peninsula Recreation Service Area for the project; and
- WHEREAS, at its regular meeting on August 22, 2011, the NPRSA service area board of directors recommended acceptance of both grants;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept, on behalf of the North Peninsula Recreation Service Area, two grants from the Department of Commerce, Community and Economic Development in the amount of \$225,000 for the community playground project, and is authorized to execute the grant agreements and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That grant funds in the amount of \$75,000 are hereby appropriated to 459.61110.12382.48521, a project account.
- **SECTION 3.** That grant funds in the amount of \$150,000 are hereby appropriated to 459.61110.12028.48521, a project account.
- **SECTION 4.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

**SECTION 5.** This ordinance shall become effective immediately upon its enactment.
