KENAI PENINSULA BOROUGH ORDINANCE 2011-19-55

AN ORDINANCE APPROPRIATING \$98,722 IN SUPPLEMENTAL FUNDING FOR TWO (2) NEW ROSITIONS AND ASSOCIATED COSTS AT THE RIVER CENTER

- WHEREAS, on June 21, 2011, the assembly enacted Ordinance 2011-12 which amended KPB 21.18.025 to include all anadromous streams in the Kenai Peninsula Borough in the habitat protection district excluding those within the Seward-Bear Creek Flood Service Area; and
- WHEREAS, this expansion of the habitat protection district was extensive as it added approximately 2,317 stream miles to the 602 stream miles previously included in the district; and
- WHEREAS, implementation and enforcement of this expanded area will require additional personnel including one resource planner and one senior clerk typist in the river center department; and
- WHEREAS, the estimated annual cost for the two (2) new positions including personnel cost, supplies, and other related expenditures is approximately \$167,689; and
- WHEREAS, for the six months remaining in FY2012, the estimated cost of implementing the provision of Ordinance 2011-12 is approximately \$98,722; including personnel cost including benefits of \$77,670; supplies of \$750, services of \$9,890 and equipment of \$10,412;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$98,722 is appropriated from the general fund fund balance to the following accounts for costs associated to fully fund a resource planner and a senior clerk typist and provide for associated required personnel costs:
