Dear Municipal Official:

The Division of Community and Regional Affairs (DCRA) is pleased to notify you that the 27th Alaska State Legislature appropriated an additional \$20 million dollars for payments under the FY 2012 Community Revenue Sharing (CRS) program "to be distributed proportionally to the amounts received by communities under AS 29.60.855 and AS 29.60.860" (Chapter 3, FSSL 11).

The proportional payment for the Kenai Peninsula Borough has been estimated to be \$716,984.

In addition to the above mentioned estimated payment, the borough will receive an additional estimated proportional payment of \$6,733 on behalf of each unincorporated community. For the FY 12 CRS program year, the Kenai Peninsula Borough certified 27 unincorporated communities for a total of \$181,791.

The Department will begin making proportional payments in early November. To receive the proportional FY 12 Community Revenue Sharing payment, the Kenai Peninsula Borough must complete and return the attached application / budget form. To ensure the timely processing of your payment, please return the completed application / budget form as soon as possible.


