## KENAI PENINSULA BOROUGH ORDINANCE 2011-19-56

## AN ORDINANCE ACCEPTING AND APPROPRIATING FUNDING FROM THE STATE OF ALASKA IN THE AMOUNT OF \$181,791 FOR COMMUNITY PURPOSES UNDER THE STATE'S 2011/2012 COMMUNITY REVENUE SHARING PROGRAM

- WHEREAS, through adoption of KPB Resolution 2011-043, the assembly certified that 27 unincorporated communities within the Kenai Peninsula Borough are eligible for participation in the State's 2011/2012 Community Revenue Sharing Program; and
- WHEREAS, the State Legislature has provided a one-time proportional payment to qualified unincorporated communities through the Community Revenue Sharing Program; and
- WHEREAS, the additional funds in the amount of \$181,791 have been received from the Alaska Department of Commerce, Community and Economic Development to be distributed proportionally under AS 29.60.855 and AS 29.60.860 (Chapter 3, FSSL II); and
- WHEREAS, the \$181,791 is to be distributed evenly among the 27 unincorporated communities within the borough; and
- WHEREAS, the Community Revenue Sharing Program allows funds to be used for any public purpose at the discretion of the local governing body and as allowed by state statutes and borough code; and
- **WHEREAS,** it is in the best interest of the borough to accept these state funds on behalf of the 27 unincorporated communities;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept \$181,791 from the State of Alaska for distribution to eligible communities.
- **SECTION 2.** That the mayor is authorized to execute grant amendments and any other documents necessary with tribal or nonprofit organizations on behalf of the qualified unincorporated communities for public projects that benefit the community as identified in the following chart:
