RE:	Veto of Ordinance 2011-24, Amending KPB 22.30.030 to Redefine a Full Term Of Office With Respect To Assembly Term Limits

I have spent a great deal of time deliberating the enactment of Kenai Peninsula Borough Ordinance 2011-24 which amends the borough code to redefine a term of office for assembly members with respect to term limits. While I am quite reluctant to exercise the mayor's veto authority, for the reasons stated below I have decided to veto ordinance 2011-24 and hereby do so.

As a preliminary matter I wish to clarify that this veto is not related to the issue of term limits, nor is it intended as a criticism of the final product.

Instead, my essential objection is that the process did not provide adequate public notice and opportunity for public comment on the amendments first presented and approved on August 2, 2011. These amendments eliminated the voter approval requirement, increased the number of years an assembly member can serve, and extensively changed the title. After consultation with the legal department, I believe these changes were significant. Everything noticed stated the changes being considered would be put before the voters.

AS 29.20.270 provides that a veto may be overridden within 21 days following the exercise of the veto or the next regular meeting, whichever is later. Respectfully I submit this matter for your deliberation.

THE PRIMARY CONCERN ...

Should the people of the Peninsula decide the details pertaining to how their elected leaders will serve them, OR the other way around? By my evaluation this was an inappropriate action and the Borough Mayor should VETO the Assembly's decision.
