In listening to the last meeting, and thinking about what the Assembly is endeavoring to accomplish, I looked up the language as it is written in Borough Code for the Mayor, who also serves under a 2 term limit. However, that language very much clarifies what constitutes a term.

## 2.04.010. - Term of office—Limitation of terms.

The term of office of the borough mayor is 3 years. No person who has completed two consecutive full terms as mayor may serve another term or portion of a term until a period of 180 days has passed since the end of their second consecutive full term of office. A full term of office means the regular term of office for mayor and does not include portions of a term served by appointment or election to the remainder of an unexpired term vacated by another person.

My suggestion is utilize the Mayor's language, to be enacted when the October election is certified. I was hoping it could be done as housekeeping, but the initiative was very clear, two terms including portions thereof. Therefore it has to wait the two full years.
