CITY OF SELDOVIA ORDINANCE 12-02

A NON-CODE ORDINANCE OF THE CITY OF SELDOVIA APPROVING THE INCLUSION OF THE CITY OF SELDOVIA IN THE PROPOSED SELDOVIA RECREATIONAL SERVICE AREA IF THE SERVICE AREA IS APPROVED BY THE VOTERS

WHEREAS, the City of Seldovia is a first class, general law city located in the Kenai Peninsula Borough (KPB); and

WHEREAS, following the receipt of a petition to form a service area signed by at least the KPB Assembly is considering ordinance 2011-28, which would establish the KPB Seldovia Recreational Service Area subject to voter approval; and

WHEREAS, pursuant to Alaska Statute 29.35.450, a borough may include a city in a service area if (1) the city agrees by ordinance; or (2) approval is granted by a majority of voters residing in the city, and by majority of voters residing outside the city but inside the boundaries of the proposed service area; and

WHEREAS, the proposed service area would provide recreational services including services that are based out of and utilize the Seldovia Community Center, now known as the Sea Otter Community Center, presently; located adjacent to Susan B. English School and other facilities as my be authorized by the borough assembly, and additional recreational services as are recommended by the service area board and established by the assembly through the budget process

WHEREAS, services to be provided may include but are not limited to senior citizen and youth programs, musical instruction and practice, accommodation of visiting schools during "Sea Week" and other Seldovia field trips, facility rental for organizations and individuals for meetings and celebrations, adult education, high speed internet access, community gatherings such as potlucks and dinners, karate instruction, arts and crafts instruction and facilitation, nature education and outdoor activities; and

WHEREAS, the services shall be different from those provided by the City of Seldovia, and

WHEREAS, the best interests of the City of Seldovia would be served by being included in this service area because it will enhance the quality of living for Seldovia and the surrounding area by having this facility open for various programs.

NOW THEREFORE BE ORDAINED BY THE COUNCIL OF THE CITY OF SELDOVIA, ALASKA:

SECTION 1. This is a non-code ordinance.

<u>SECTION 2.</u> That the Council of the City of Seldovia agrees that the City of Seldovia may be included in the proposed Seldovia Recreational Service Area if the service area is approved by the borough assembly and the voters of the proposed service area.

SECTION 3. This ordinance becomes effective upon adoption.
