**KENAI PENINSULA BOROUGH
ORDINANCE 2011-29**

AN ORDINANCE AUTHORIZING THE ASSESSOR TO ACCEPT THE LATE-FILED SENIOR CITIZEN EXEMPTION APPLICATIONS OF KATHLEEN FINN, JIMMIE L. BOYD, SHIRLEY A. BAILEY AND THEODORE J. FORSI, JR. FOR 2011

WHEREAS, KPB 5.12.105(E) provides that a late application for a senior citizen exemption must be filed by March 31 of the year for which the exemption is sought; and

WHEREAS, AS 29.45.030(f) authorizes the governing body to waive the deadline for good cause shown; and

WHEREAS, because this requirement is established by ordinance, an exception to it can only be granted by ordinance; and

WHEREAS, Resolution 2011-039 was introduced on April 19, 2011, and adopted on May 3, 2011, at which time several waivers were denied; and

WHEREAS, since the initial introduction of Resolution 2011-039, the mayor's office has received new information regarding two of the late-filed exemptions; and

WHEREAS, the late-filed senior citizen exemption application of Jimmie L. Boyd has been received for processing with a request for waiver of the 2011 application submission deadline; and

WHEREAS, the late-filed senior citizen exemption application of Kathleen Finn has been received for processing with a request for waiver of the 2011 application submission deadline;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. Upon reviewing the applications and affidavits submitted with this ordinance, pursuant to KPB 5.12.105(E) the assembly finds good cause for waiving the March 31 deadline for filing the Senior Citizen Exemption applications set out in Section 2 below and that the applicant in Section 3 was unable to comply with the March 31 deadline.

SECTION 2. That the deadline for filing application for the senior citizen real property exemption for the following parcels are hereby waived for good cause for the following applications:


SECTION 3. That the March 31st deadline for filing an application for the senior citizen real property exemption for the following parcel is hereby waived as the applicant was unable to comply with that deadline:

SECTION 4. That the Assessor shall process the application in accordance with standard assessing department procedures for processing such applications.


SECTION 5. That this ordinance takes effect immediately upon its enactment.

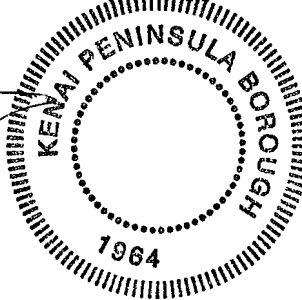
