**KENAI PENINSULA BOROUGH
ORDINANCE 2011-19-83**

**AN ORDINANCE APPROPRIATING \$26,145.80 FROM FUND BALANCE FOR THE
PURCHASE OF SUPPLIES AND EQUIPMENT BY THE LOWELL POINT
EMERGENCY SERVICE AREA**

WHEREAS, the Lowell Point Emergency Service Area (Service Area) ended FY2011 with an available fund balance of \$26,145.80; and

WHEREAS, on October 4, 2011, the Service Area voters voted to dissolve the Service Area effective July 1, 2012; and

WHEREAS, if the funds are not expended they will revert to the borough's general fund; and

WHEREAS, the Service Area board would like to appropriate the existing fund balance for the purchase of supplies and equipment needed for fire and emergency services; and

WHEREAS, the Service Area board at its April 10, 2012, meeting authorized the use of \$26,145.80 of fund balance in FY2012 to purchase the necessary items; and

WHEREAS, approval by the assembly is necessary to appropriate the additional funds; and

WHEREAS, unless any purchased assets are transferred prior to June 30, 2012, it is most likely the assets would revert back to the borough and could only be used in a service area where the borough has the authorization to exercise fire and emergency services powers or be sold for market value, similar to other non-grant acquired assets owned by the Service Area;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the amount of \$26,145.80 is hereby appropriated from the Lowell Point Emergency Service Area, fund balance to the following accounts:



SECTION 2. That any subsequent transfer of these assets must comply with the public purpose doctrine as stated in Article IX, Section 6 of the Alaska Constitution and other applicable law.

SECTION 3. That all funds appropriated from the Lowell Point Emergency Service Area fund balance must be spent before July 1, 2012.


SECTION 4. That this ordinance takes effect immediately upon its enactment.

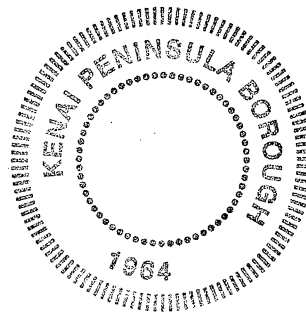
