PROPOSITION: "Shall the Kenai Peninsula Borough provide an an exemption from real property taxes not to exceed a maximum amount of \$250.00 of such tax on residential real property owned or partly owned and occupied as a permanent place of abode by a resident 65 years or more and which property is ineligible for exemption under state law because of income limitations on the owner or owners or which is owned or partly owned and occupied as a permanent place of abode by a resident disabled within the meaning of the U. S. Social Security Act?"

NOW, THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH DECLARES:

- 1. That John C. Davis, Bill Chenault and Ray Burton, Sr. received 711, 752 and 698 votes respectively and are elected to three year terms on the borough assembly. Each received in excess of 40% of the votes cast for the respective office.
- 2. That Max Hamilton and Ronald Mika received 553 and 575 votes respectively for the one-one year assembly seat. As neither candidate received the required 40% (652) necessary to be elected, he shall therefore be a candidate in the run-off election scheduled for October 23, 1973.
- 3. That Luther N. Abrahamson, K. Lewis Fields, Robert E. Glud and Forrest Tressler received 1,116, 964, 1,117 and 1,014 votes for the two-three year seats on the school board. As none of these candidates, who received the highest number of votes, received the 40% (1248.2) necessary to be elected, these candidates shall therefore have their names placed in the run-off election scheduled for October 23, 1973.
- 4. That Edward E. Hollier received 1,455 votes for the one-two year term on the school board, which amount is in excess of the 40% (1,254) votes required for the two year term and therefore he is elected to this seat.
- 5. That the proposition received 2,544 "Yes" votes and 463 "No" votes and is declared approved by the voters.
- 6. That the following candidates received the highest vote for positions on the North Kenai Fire Service Area Board and are hereby elected:

Seat A. Ronald Mika 3 yr. term
Seat B. Charles Koehler 3 yr. term
Seat C. Sandra D. Toloff 2 yr. term
Seat D. John H. Neilsen 2 yr. term
Seat E. Lloyd Kingery 1 yr. term

7. That the following candidates received the highest vote for positions on the South Peninsula Hospital Service Area Board and are hereby elected:
