NOW, THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH DECLARES:

- 1. That Tommy Corr, John C. Davis, and Jean B. Douglas received 736, 840, and 850 votes respectively and are elected to three year terms on the borough assembly having each received in excess of 40% (402) of the votes cast for those seats and Margaret A. Branson received 1009 votes and is elected to a 1 year term on the borough assembly.
- 2. That Joyce W. Fischer and Sandra G. Morris received 2035 and 1789 votes respectively and are elected to 3 year terms on the school board; Sheila Owens having received 2200 votes is elected to a 2 year term and Sharon M. Brower having received 1313 votes is elected to a 1 year term on the school board.
