**KENAI PENINSULA BOROUGH
RESOLUTION 91-146**

**CONDITIONAL ACCEPTANCE OF THAT PORTION OF THE EXISTING
EXIT GLACIER ROAD LYING BETWEEN THE SEWARD HIGHWAY AND
MILEPOST 1.6 OF THE EXISTING ROAD ONTO THE BOROUGH ROAD
MAINTENANCE SYSTEM**

WHEREAS, the Federal Highway Administration (FHWA) working in concert with the State of Alaska, Department of Transportation and Public Facilities (DOT&PF) has completed design work for construction and upgrade of the Exit Glacier Road near Seward, Alaska; and

WHEREAS, FHWA and DOT&PF are now prepared to initiate the construction phase of the project which will have a total cost of approximately \$6 Million; and

WHEREAS, Federal funding of the project requires a matching local share to be contributed by State and local governments which in this case equals approximately \$3 Million; and

WHEREAS, the State of Alaska has agreed to fund the entire local share without contribution by the Kenai Peninsula Borough provided that the Borough accept responsibility to continue maintenance on the initial 1.6 miles of the existing road which will be bypassed by the new construction; and

WHEREAS, KPB Chapter 14.06 sets out "Road Standards" which must be met in order to accept a new road onto the Borough's road maintenance system, which standards are not met by the existing Exit Glacier Road; and

WHEREAS, the Kenai Peninsula Borough Road Maintenance Service Area Board held public hearing on this matter in Seward, Alaska, on November 15, 1991, and, following close of hearing, voted to request that the Assembly condition acceptance of the road segment by requiring the road to be brought up the standards set by KPB Chapter 14.06 for acceptance of any road onto the road maintenance system;


NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the portion of the existing Exit Glacier Road which lies between the Seward Highway and Milepost 1.6, and which will be bypassed by construction of the


new Exit Glacier Road Project will be accepted for maintenance upon the Borough road maintenance system at such time as application is made and showing is made that the road meets all requirements set out by KPB Chapter 14.06 "Road Standards."

Section 2. That this resolution shall take effect immediately upon its adoption.
