**KENAI PENINSULA BOROUGH
RESOLUTION 92-34**

A RESOLUTION CLASSIFYING BOROUGH LANDS LOCATED WITHIN PORTIONS OF SECTIONS 12, 13 AND 14, TOWNSHIP 4 NORTH, RANGE 11 WEST, SEWARD MERIDIAN AS "RETAINED FOR SOLDOTNA LANDFILL AND ASSOCIATED USES"

WHEREAS, the borough has received title to certain lands pursuant to the Municipal Entitlement Act and has purchased certain other lands; and

WHEREAS, the Kenai Peninsula Borough Public Works Department has requested that previously unclassified lands be classified for use in conjunction with the existing Soldotna Landfill; and

WHEREAS, Resolution 81-207 classified a portion of the area as "sale to the public" and a portion as "for use as the landfill and cover material source areas"; and

WHEREAS, Resolution 87-1 classified a portion of the existing Soldotna Landfill as "approved the use of KPB lands for the entire Soldotna Landfill site including solid waste disposal areas and cover material source areas"; and

WHEREAS, it is not desirable that the lands surrounding the Soldotna Landfill be sold to the public; and

WHEREAS, the lands should be reclassified for the landfill and associated uses; and

WHEREAS, the Kenai Peninsula Borough Planning Commission considered this classification at its March 9, 1992 meeting and recommended approval;

NOW THEREFORE BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


Section 1. That the following described lands are hereby classified as "Retained for Soldotna Landfill and Associated Uses":

- (1) N½ of Section 13, T4N, R11W, S.M.;
- (2) Lot 2, Sterling Forest Subdivision, within Section 12, T4N, R11W, S.M.;


- (3) SE $\frac{1}{4}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ and the E $\frac{1}{2}$ all lying easterly of the Sterling Highway within Section 12, T4N, R11W, S.M. excepting therefrom that portion of the E $\frac{1}{2}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ lying southeasterly of the Sterling Highway;
- (4) NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 14, T4N, R11W, S.M.;
- (5) N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 13, T4N, R11W, S.M. excepting therefrom Tract 1 Kananen Subdivision;
- (6) Lots 1, 2 and 3 Block 1, Kananen Subdivision, within Section 13, T4N, R11W, S.M.

Section 2. That this resolution shall take effect immediately upon adoption.
