**A RESOLUTION AWARDING CONTRACTS FOR RADIO BROADCASTING
BOROUGH ASSEMBLY MEETINGS FOR FISCAL YEAR 1993**

WHEREAS, sealed bids were requested and received for the broadcasting of borough assembly meetings for the fiscal year 1993; and

WHEREAS, negotiations were conducted thereafter with KSRM and KSWD; and

WHEREAS, after negotiations radio station KSRM submitted an offer of \$495.00 per meeting to provide broadcasting of assembly meetings from the Assembly Room, plus actual long distance phone charges to provide a feed to other selected borough stations in Homer and Seward; and

WHEREAS, radio station KGTL submitted a bid of \$405.00 per meeting plus \$90.00 per hour for coverage after midnight to provide broadcasting of assembly meetings in the Homer area; and

WHEREAS, after negotiations radio station KSWD submitted an offer of \$405.00 per meeting to provide broadcasting of assembly meetings in the Seward area;

NOW THEREFORE, BE IT ADOPTED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That a contract is awarded to radio station KSRM to provide broadcasting of borough assembly meetings for the fiscal year 1993 at a cost of \$495.00 per meeting plus actual long distance phone charges for feeds to participating stations in Seward and Homer.


SECTION 2. That a contract is awarded to radio station KGTL to provide broadcasting of borough assembly meetings in the Homer area for the fiscal year 1993 at a cost of \$405.00 per meeting plus \$90.00 per hour after midnight.

SECTION 3. That a contract is awarded to radio station KSWD to provide broadcasting of borough assembly meetings in the Seward area for the fiscal year 1993 at a cost of \$405.00 per meeting plus \$90.00 per hour after midnight.

SECTION 4. That the first meeting to be broadcast under these contracts will be the first assembly meeting in August 1992.


SECTION 5. That this resolution takes effect immediately upon its adoption.
