NOW THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH
 DECLARES:

SECTION 1. That in the Borough-wide election for School District, Seat F, Mike Tauriainen, and Seat G, Betty Obendorf were elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.

SECTION 2. That in Assembly District 1, Betty Glick was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.

SECTION 3. That in Assembly District 2, Emery Thibodeau was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.

SECTION 4. That in Assembly District 3, Jack Brown was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.

SECTION 5. That in Assembly District 4, Sharon Moock was elected having received the

highest vote tallies and in excess of the required forty (40%) percent of the vote.

- SECTION 6.** That in Assembly District 5, Grace Merkes was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 7.** That in Assembly District 6, Pat Reilly was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 8.** That in Assembly District 7, John Torgerson was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 9.** That in Assembly District 8, Burt Anderson was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 10.** That in Assembly District 9, Drew Scalzi was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 11.** That in the areawide vote, Proposition 1, an advisory vote on limitation of terms of the mayor, assembly and school board members, was approved by the voters areawide.
- SECTION 12.** That in the areawide vote, Proposition 2, authorizing \$8,655,000 in bonded indebtedness for additions to Tustumena Elementary School, was not approved by the voters areawide.
- SECTION 13.** That in the areawide vote, Proposition 3, authorizing \$8,655,000 in bonded indebtedness for renovation to Kenai Elementary School, was not approved by the voters areawide.
- SECTION 14.** That in the Kenai Peninsula Borough Road Service Area, Proposition 4, approving .5 mill for maintenance and improvements on roads, was approved by the voters of the service area.
- SECTION 15.** That in the Anchor Point Fire and Emergency Service Area, Seat A, Keith Swisher was elected by write-in vote to a 1 year term; and, Seat B, R. J. Austin was elected to a 3 year term.
- SECTION 16.** That in the Bear Creek Fire Service Area, Seat A, Kent Burklund was elected to a 3 year term; Seat B, George Zimmerman was elected to a 3 year term; and, Seat C, Robin Hayes was elected to a 2 year term.


SECTION 13. That for the Joint Operations Board for the Central Peninsula Emergency Medical Services and the Central Emergency Services Service Areas, Seat A, Kenneth Hepner was elected to a 3 year term; Seat B, Ken Lancaster was elected to a 3 year term; Seat C, Harry Lockwood, was elected to a 2 year term; Seat D, Tom Hodel was elected to a 2 year term; and, Seat E, Dave Carey was elected to a 1 year term.

SECTION 14. That in the Nikiski Fire Service Area, Seat A, Mae Leighton was elected to a 3 year term, Seat B, Jack Focose was elected to a 3 year term, Seat C, Steve Hoogland was elected to a 3 year term; and, Seat D, Preston Williams was elected to a 3 year term.


