**KENAI PENINSULA BOROUGH  
RESOLUTION 92-112**

**A RESOLUTION RELINQUISHING THE BOROUGH'S SELECTION OF LANDS  
KNOWN AS THE HOPE AIRSTRIP AND THE LAWING AIRSTRIP**

**WHEREAS**, the borough's municipal selections include the Hope Airstrip and the Lawing Airstrip; and

**WHEREAS**, the Hope Community Land Use Plan as prepared by the Hope/Sunrise Advisory Planning Commission indicates that the Hope Airstrip remain under the State of Alaska Department of Transportation and Public Facilities; and

**WHEREAS**, it is not in the best interest of the borough to receive title to these areas; and

**WHEREAS**, the State has indicated it would be more efficient for the borough to relinquish the selections of the two airstrips than the State issuing a decision rejecting the selections;

**NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the borough hereby relinquishes its selection of the following described lands encompassing the Hope Airstrip and containing a total of 74.83 acres, more or less:

Hope Airport Tract I: A parcel of land lying within unsurveyed Sections 33 and 34, T10N, R2W, and Sections 3 and 4, T9N, R2W, Seward Meridian, Alaska, more particularly described as commencing at corner No. 1 of HES 247, USS 2636 being the point of beginning;

thence N06°54'40"E 1580.81 feet,

thence West 680.91 feet,

thence S04°07'38"W 1036.52 feet,

thence N85°52'22"W 400 feet,

thence S04°07'38"W 1200.00 feet,

thence S85°55'22"E 400.00 feet,

thence S04°07'38"W 1906.00 feet,

thence N44°00'E 526.00 feet,

thence N41°54'39"E 681.34 feet,  
thence N01°05'W 1676.99 feet to the point of beginning,  
containing 68.19 acres, more or less.

Hope Airport Tract III: A parcel of land lying within unsurveyed Section 34, T10N, R2W, Seward Meridian, Alaska, more particularly described as commencing at corner No. 1 of HES 247 USS 2636 proceed N06°54'40"E 1580.81 feet, thence West 11.44 feet to the point of beginning;  
thence West 265.75 feet,  
thence North 131.79 feet,  
thence S83°05'20"E 289.56 feet,  
thence S12°37'18"W 99.35 feet to the point of beginning,  
containing 0.73 acres, more or less.


Hope Airport Tract IV: A parcel of land lying within unsurveyed Section 33, T10N, R2W, Seward Meridian, Alaska, more particularly described as commencing at corner No. 1 of HES 247 USS 2636 proceed N56°58'08"W 1144.99 feet to the point of beginning;  
thence N85°52'22"W 445.00 feet,  
thence S00°04'W 60.15 feet,  
thence S85°52'22"E 440.74 feet,  
thence N04°07'38"E 60.00 feet to the point of beginning,  
containing 0.61 acres, more or less.

Hope Airport Tract V: A parcel of land lying within unsurveyed Sections 3 and 4, T9N, R2W, Seward Meridian, Alaska, more particularly described as commencing at corner No. 1 of HES 247 USS 2636 proceed S44°35'19"W 928.22 feet to the point of beginning;  
thence N85°55'22"W 123.00 feet,  
thence S04°07'38"W 1390.00 feet,  
thence S15°19'E 173.83 feet,  
thence S20°13'W 238.34 feet,  
thence S03°00'E 135.05 feet,  
thence S46°01'05"E 83.00 feet,  
thence N44°00'E 93.61 feet,  
thence N04°07'38"E 1906.00 feet to the point of beginning,  
containing 5.30 acres, more or less.


