KENAI PENINSULA BOROUGH RESOLUTION 93-101

A RESOLUTION URGING DELETION OF CERTAIN TRACTS IN THE SOUTHERN KENAI PENINSULA FROM THE PROPOSED STATE OIL AND GAS LEASE SALE 78

- WHEREAS, the State of Alaska Department of Natural Resources, Division of Oil and Gas, has issued a call for comments on State Lease Sale 78; and
- WHEREAS, the Kenai Peninsula Borough, in conjunction with the Division of Oil and Gas, held a public hearing to solicit public comment on the proposed Lease Sale 78; and
- WHEREAS, more than 75 percent of the public testifying at the public hearing requested deletion of tracts located on the southern Kenai Peninsula in the Homer area; and
- WHEREAS, oil and gas companies who have commented on the proposed lease sale show little, if any, interest in tracts south of Starisky Creek; and
- WHEREAS, it is the desire of the Kenai Peninsula Borough to proceed with an orderly lease sale which will provide for exploration of high potential oil and gas prospects but at the same time minimizing the impact on private land owners and citizens of the area;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. The Kenai Peninsula Borough Assembly finds that it is in the best interests of the Kenai Peninsula Borough and its citizens to delete the tracts which are identified in Exhibit A from State Oil and Gas Lease Sale 78.
- SECTION 2. The Borough Clerk is instructed to send a copy of this Resolution to Governor Walter J. Hickel; Commissioner Natural Resources, Harry Noah; Director of Oil and Gas Division, James Eason; Senator Judy Salo; Senator Suzanne Little; Representative Gail Phillips; and Representative Gary Davis.
- **SECTION 3.** That this Resolution takes effect immediately upon its adoption.
