- WHEREAS, Resolution 93-70 and 93-102 classified Borough lands as Resource Extraction for timber harvest pursuant to KPB 17.10.170; and
- WHEREAS, Ordinance 94-16 amended sections within KPB 17.10 and deleted the "Resource Extraction" classification and added Resource Development and Resource Management classifications; and
- WHEREAS, those lands originally classified Resource Extraction should be classified Resource Management to comply with KPB Code 17.10; and
- WHEREAS, the Borough Planning Commission in regular session on September 12, 1994 recommended adoption by unanimous consent;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That those Borough lands classified under Resolution 93-70 and 93-102 (see Exhibit A) as Resource Extraction are hereby reclassified as Resource Management.
- **SECTION 2.** That this reclassification is for the purpose of forest and timber management and shall be subject to the terms and provisions of KPB 17.50.
- SECTION 3. That this classification shall take effect immediately upon adoption of this resolution.
