DECLARES:**


- SECTION 1.** That in the Borough-wide election for School Board, Seat D, Susan Larned, and Seat E, Mari-Anne Gross were elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 2.** That in Assembly District 1, Betty J. Glick was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 3.** That in Assembly District 6, Mike Wiley was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.

- SECTION 4.** That in Assembly District 9, Drew Scalzi was elected having received the highest vote tallies and in excess of the required forty (40%) percent of the vote.
- SECTION 5.** That in the areawide vote, Proposition 1, general obligation bonds for a new Homer elementary school, was approved by the voters areawide.
- SECTION 6.** That in the South Peninsula Hospital Service Area, Proposition 2, expanding the authorities of the service area, was approved by the voters of the service area.
- SECTION 7.** That in the Anchor Point Fire and Emergency Service Area, Seat B, Joe Tracy, was elected by write-in votes to a 1-year term; Seat C, R. J. Austin was elected to a 3-year term; and, Seat D, Robert Craig, was elected to a 3-year term..
- SECTION 8.** That in the Bear Creek Fire Service Area, Seat B, Gary Zimmerman, Seat C, Dan Logan, were elected by write-in votes to a 3-year term; and, Seat D, no candidate was elected.
- SECTION 9.** That for the Joint Operations Board for the Central Peninsula Emergency Medical Services and the Central Emergency Services Service Areas, Seat C, Harry Lockwood, and Seat D, Martin Hall, were elected to 3-year terms.
- SECTION 10.** That in the Nikiski Fire Service Area, Seat F, Bernie Smith, and, Seat G, Jeffrey Stadheim, were elected to 3-year terms.
- SECTION 11.** That in the Nikiski Senior Service Area, Seat A, Loretta Brown was elected to a 3-year term; and, Seat B, Clifford Koivisto was elected to a 1-year term.
- SECTION 12.** That in the North Peninsula Recreation Service Area, Seat C, Peter Mysing, was elected to a 3-year term, and, Seat D, Marion Nelson, was elected for a 3-year term.
- SECTION 13.** That in the South Peninsula Hospital Service Area, Seat A, Richard Ingle was elected to a 3-year term; and, Seat B, Vickey Hodnik, and Seat C, Willie Flyum were elected by write-in votes to 3-year terms.
