

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**


- SECTION 1.** That in Assembly District 1, Gary Knopp was elected to a 3-year term, having received the greatest number of votes cast.

Seat D - James E. “Jim” Chambers for a 3-year term

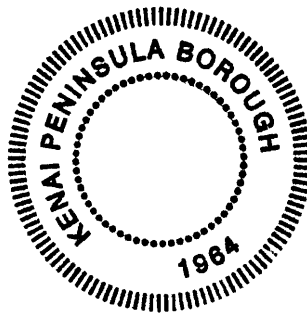
- SECTION 12.** That in the Kachemak Emergency Service Area, the following were elected, having received the greatest number of votes cast:
