**KENAI PENINSULA BOROUGH  
RESOLUTION 2006-090**

**A RESOLUTION WAIVING SOLID WASTE COLLECTION FEES  
ESTABLISHED IN RESOLUTION 98-081 FOR DEBRIS FROM THE  
OCTOBER 2006 FLOOD EVENT IN THE SEWARD AREA**

**WHEREAS,** a declaration of disaster was declared for the Seward area due to flooding on October 9, 2006; and

**WHEREAS,** the flood has resulted in large amounts of flood-related debris that poses safety and health threats if it is not properly disposed of, which include a large variety of offal, garbage, wood, ruins, refuse, rubbish, and human waste; and

**WHEREAS,** the mayor issued a deferment of fees in accordance with Section 2 of Resolution 98-081 for Seward flood-related debris for a 46-day period beginning October 12, 2006, and ending November 27, 2006; and

**WHEREAS,** Resolution 98-081 established a fee schedule for solid waste deliveries exceeding five cubic yards; and

**WHEREAS,** citizens are suddenly in the position of having waste exceeding five cubic yards due to flood damage, which waste poses a threat to public safety and health if not expediently disposed of properly; and

**WHEREAS,** it is in the best interest of the community to encourage the prompt and thorough disposal of flood debris by waiving fees for flood related debris;


**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** Notwithstanding Section 3 of Resolution 98-081, the fees for solid waste debris resulting from the Seward flood event subject to the October 9, 2006, declaration of disaster are waived for a period of 46 days from October 12, 2006, until November 27, 2006.


**SECTION 2.** This resolution does not authorize waste to be disposed of at Kenai Peninsula Borough landfills which are not otherwise authorized for disposal at borough landfills by the Kenai Peninsula Borough Code.

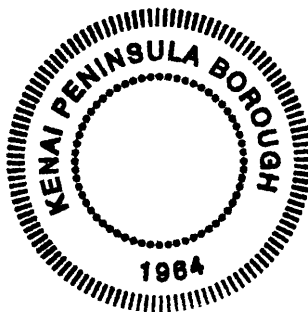
**SECTION 3.** This resolution takes effect retroactively on October 12, 2006.
