**KENAI PENINSULA BOROUGH
RESOLUTION 2011-018**

**A RESOLUTION DETERMINING THE MINIMUM AMOUNT TO BE PROVIDED
FROM LOCAL SOURCES FOR SCHOOL PURPOSES DURING FISCAL YEAR 2012**

- WHEREAS,** in accordance with Alaska Statute 14.14.060(c) and KPB 5.04.021 the school district shall submit the school budget for approval of the total amount, and the assembly must determine the total amount of money to be made available from local sources for school purposes and must furnish to the school board a statement of the sum to be made available within 30 days of receipt of the budget; and
- WHEREAS,** AS 14.20.140 requires the district to provide notice to tenured teachers who are to be laid off or not retained for the following school year before March 16 each year; and
- WHEREAS,** the district may be forced to issue such notices this year due to uncertainty regarding the level of borough funding that may be provided for school purposes; and
- WHEREAS,** providing the school district with a minimum funding level for fiscal year 2012 will assist the district in preparing its budget and determining whether to send the notices to its employees; and
- WHEREAS,** the best interests of the community would be served by providing such information as it would provide a greater sense of security and stability regarding on-going operations and employment of the school district; and
- WHEREAS,** the assembly intends that this notice shall constitute the statement of the sum to be made available from local sources in that the amount provided shall not be reduced absent a significant unforeseen economic event leaving the borough without sufficient funds to provide this amount for school purposes for fiscal year 2012; and
- WHEREAS,** the assembly finds that providing funding for school purposes at a minimum of \$43,251,135, which is equal to the funds provided for fiscal year 2011, is in the best interests of the borough and school district;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


SECTION 1. That \$43,251,135 shall be made available from local sources to fund school district operations for Fiscal Year 2012 including local effort, borough maintenance, school district utilities, insurance, audit expenses, and custodial services.

SECTION 2. That a resolution approving the total amount of the school district budget, restating the amount to be made available from local sources in an amount equal to or greater than \$43,251,135 for local effort, borough maintenance, school district utilities, insurance, audit expenses, and custodial services shall be considered within 30 days after receipt of the school district budget.

SECTION 3. That a copy of this resolution shall be sent to the President of the Board of Education upon its adoption.

SECTION 4. That this resolution takes effect immediately upon its adoption.

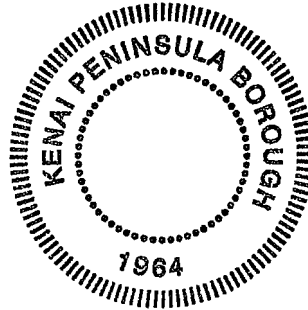
