KPB Resolution 2011-060 was submitted with blanks for consideration at the June 7, 2011, assembly meeting. This memo and accompanying bid tab includes the information to fill in the blanks.

The Kenai Peninsula Borough Road Service Area solicited bids for Moat Way, Excaliber Way and Camelot Drive Capital Improvement Project #E3MOA for completion in summer 2011. The lowest responsive bid was received from Metco, Inc. in the amount of \$329,627.00 for the Moat Way, Excaliber Way and Camelot Drive project. The total cost for this project is \$394,099.00 which includes RSA project management wages, engineering, construction costs, interdepartmental charges, and contingency.

This project is submitted to the assembly for approval because funds for CIP's have only been appropriated by the assembly but not yet allocated. This project has been approved through Road Service Area Resolution 2009-10 Approving the FY2011 Capital Improvement Projects.

Please add the following language to fill in the blanks on resolution 2011-060.

➤ Amend the 5th whereas clause at line 11 as follows:

WHEREAS, the RSA has solicited and received two (2) bids for the RSA Capital Improvement Project: Moat Way, Excaliber Way and Camelot Drive #E3MOA; and

 \triangleright Amend the 6th whereas clause at line 15 as follows:

WHEREAS, the bids have been reviewed by the RSA and the low responsive bid was submitted by Metco, Inc.;

Amend section 1 of the resolution at line 3 and 5 as follows:

SECTION 1. That the mayor is authorized to award a contract to Metco, Inc. to perform the work for RSA Capital Improvement Project: Moat Way, Excaliber Way and Camelot Drive #E3MOA for the bid amount of \$329,627.00.

Amend section 2 of the resolution at line 6 as follows:

SECTION 2. That the mayor is authorized to allocate project cost, \$394,099.00 to account number 434.33950.E3MOA.49999.
