KPB Resolution 2011-077 was submitted with blanks for consideration at the August 2, 2011 assembly meeting. This memo and accompanying bid tab includes the information to fill in the blanks.

The Kenai Peninsula Borough Road Service Area solicited bids for Cabin Lake Drive Paving Capital Improvement Project #N1CAB for completion in summer 2011. The lowest responsive bid was received from Alaska RoadBuilders, Inc. in the amount of \$210,291.00 for the Cabin Lake Drive Paving project. The total cost for this project is \$262,915.00 which includes RSA project management wages, engineering, construction costs, inter-departmental charges, and contingency.
