The Alaska Division of Homeland Security and Emergency Management (DHS&EM) is pleased to award the Kenai Peninsula Borough the amount of \$80,000.00 under the 2011 Emergency Management Performance Grant (EMPG) for the performance period of July 01, 2011 through June 30, 2012.

Due to the return of the EMPG performance period to 12 months, all jurisdictions are receiving an adjustment to the amount of funding received in Federal Fiscal Year (FFY) 2010.

Some jurisdictions are receiving a further decrease from their annual funding allocation; this reduction reflects poor past performance. At the end of the 2010 EMPG performance period, jurisdictions turned back \$151,800.00. Therefore, several reduced award amounts were made to assist jurisdictions in meeting the ability to spend funds.

EMPG performance includes, but is not limited to, the following tasks:

- Accomplishment of projects identified in the jurisdiction's 2011 EMPG Work Plan.
- Review of the jurisdiction's Local Capability Assessment (LCA).
- Required attendance at the state's Multi-Year Training and Exercise Plan Workshop (TEPW)
 Workshop, to be held in conjunction with the spring 2012 Bi-Annual Preparedness Conference
 and development of a local jurisdiction Multi-Year Training and Exercise Plan (TEP) to be
 submitted to DHS&EM at the TEPW.
- EMPG-funded personnel should make every attempt to participate in no less than three exercises during the performance period. Exercises can be discussion—based; seminars, workshops, tabletops, games/operation simulations, or operations—based; drills, functional exercises, full scale exercises. DHS&EM sponsored opportunities will be available during the performance period. Real world events may not always count as exercise participation.
- Continued utilization of National Incident Management System Compliance Assistance Support Tool (NIMSCAST).
- Timely quarterly progress report submissions.
- Dollar-for-dollar, in-kind match.

EMPG funding allocations to local jurisdictions are a direct result of continued reporting on actual funds spent at the local level on emergency management activities. With that in mind, DHS&EM encourages reporting all funds spent on emergency management activities even if they exceed the required match.
