## KENAI PENINSULA BOROUGH RESOLUTION 2012-011

## A RESOLUTION IN SUPPORT OF CHUGACH ELECTRIC ASSOCIATION'S APPLICATION FOR STATE ASSISTANCE ON IMPROVEMENTS TO THE HOPE/SUNRISE POWER DISTRIBUTION LINE SYSTEM UPGRADES

- WHEREAS, reliable electric service is important to the safety, health and economy of residents of the Kenai Peninsula Borough; and
- WHEREAS, Chugach Electric Association (Chugach), a not-for-profit member-owned cooperative, provides electric power service to the Hope and Sunrise areas of the Kenai Peninsula Borough; and
- WHEREAS, in recent years, borough residents in Sunrise and Hope have been subjected to repeated and prolonged power outages due to a combination of events, including avalanches, the Spruce Bark Beetle infestation, wind, snow and ice storms; and
- WHEREAS, Chugach Electric Association has taken steps to improve service to Hope and Sunrise residents through a planned and systematic series of projects to clear trees and relocate and rebuild portions of the distribution line; and
- **WHEREAS,** Chugach has funded its improvements to the Hope distribution facilities through a combination of utility, state and federal funds; and
- WHEREAS, Chugach has identified two additional projects that would improve electric service to borough residents in Hope and Sunrise by adding remotely operable switches at the Hope Substation and relocating another portion of the distribution line; and
- WHEREAS, Chugach is seeking state grant funding of the two projects;

## NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

**SECTION 1.** The Kenai Peninsula Borough Assembly recognizes the importance and necessity of upgrading the electrical substation powering the Hope/Sunrise electrical distribution line and relocation of portions of the Hope electrical distribution line to safer and more accessible locations.

**SECTION 2.** The Kenai Peninsula Borough Assembly supports Chugach Electric Association's application and request to the State of Alaska for grant funding to complete the Hope Substation automation upgrade project and to relocate a portion of the Hope electrical distribution line.

**SECTION 3.** That this resolution takes effect immediately upon its adoption.
