**A RESOLUTION COMMENDING THE YOUTH RESTORATION CORPS FOR THEIR  
SUMMER OF 2000 ACHIEVEMENTS**

**WHEREAS,** the Youth Restoration Corps(YRC) has successfully completed their fourth year of projects totaling just under 1-1/2 miles of habitat restoration projects on the Kenai Peninsula, and

**WHEREAS,** the Youth Restoration Corps program has completed over 1900 lineal feet of habitat restoration this summer along the Kenai River, Russian River, and Trail River, and

**WHEREAS,** the Youth Restoration Corps has also completed over 50 acres of Fire Wise work and replanting spruce trees in the Kenai Lake area this summer, and

**WHEREAS,** another project the Youth Restoration Corps completed this summer was the 300 feet of bank restoration at the new Kenai River Center, and

**WHEREAS,** the Youth Restoration Corps provided summer jobs and hands-on education for 14 local youths and one out-of-state youth through involving the youth in their 60% work, 40% hands on educational format, and

**WHEREAS,** by promoting the Youth Restoration Corps mission of environmental stewardship we are preparing our youth, the nations greatest natural resource, for their leadership roles in the future, and

**WHEREAS,** the Youth Restoration Corps operating as a 501(C)(3) non-profit organization has worked within the community to build support on the Kenai Peninsula and around the Nation with over 100 sponsors, and

**WHEREAS,** the residents of Kenai Peninsula Borough and industries of the borough benefit from the pride and dedication that our YRC youth have shown,

**NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**
