RESOLUTION NO. 1

LEGAL STATUS - BOROUGH AND BOROUGH SCHOOL DISTRICT

WHEREAS, Chapter 52, SLA 1963, provides that the combined Seward Election District No. 9 and Kenai-Cook Inlet District No. 10 "becomes on January 1, 1964 a first or second class organized borough"; and

WHEREAS, Hugh J. Wade, Secretary of State, State of Alaska, under the date of December 13, 1963, issued the following certificate:

I, HUGH J. WADE, SECRETARY OF STATE OF THE STATE OF ALASKA, DO HEREBY CERTIFY THAT, an official State Canvass of the December 3rd Borough Incorporation Election for the combined Seward Election District No. 9 and the Kenai-Cook Inlet Election District No. 10 was held in the office of the Secretary of State at Juneau, Alaska on December 12, 1963.

That the voters of the combined Election Districts No. 9 and No. 10 chose a SECOND CLASS BOROUGH.

That the voters of the combined Election Districts No. 9 and 10 chose BOROUGH CHAIRMAN FORM OF GOVERNMENT.
